**PUBLIC COMMENTS:** Comments were made regarding the maintenance of properties, a traffic mirror on Oakdale Road, township truck inspections and also an inquiry regarding a map from the 1940's.

**APPROVAL OF MINUTES:** Chad Crawford motioned, Shaun McRoberts seconded to approve the October 12, 2015 minutes. Motion carried.

**FIRE DEPARTMENT:** Monthly report was available.

**POLICE DEPARTMENT:** Chief Filauri provided a statement stating he has been in contact with Scott Gain from the railroad. Mr. Gain stated that they have not been able to begin the repairs to the railroad due to unplanned projects. Chief Filauri intends on keeping in touch with Mr. Gain to verify progress. **ZONING OFFICER/ ENGINEER:** Engineer, Jeff Frye stated Firstly, Tim McCue has been fined \$600.00 concerning the condition of his property.
